ORDER (Dt.28.02.2024)

During spot hearing at B.M.Pur consumer camp on dt.20.02.2024 the Complainant Sri Bamana Meher appeared before the Forum in person and Sri Soumya Ranjan Das, S.D.O (Elect.), TPWODL, B.M.Pur also appeared as opposite party.

The Complainant bearing consumer no. 915202172123 stated that although power supply to the premises concerned was not released till September'2023, but surprisingly bills have been raised from November'2018 the said period. He therefore requested before the Forum to sortout and settle the issue once for all.

The opposite party on the other hand submitted a billing abstract concerning to the period from October'2020 to January'2024 along with a PVR dt.20.02.2024 which reveals that;

- 1. Bills have been raised on provisional basis from November'2018 to June'2023 and thereafter on actual basis till today.
- 2. Power supply was released on September'2023 SINCE THE 'Soubhagya' transformer not charged due to some land dispute.
- 3. The consumer has not availed the power supply from dt.05.11.2018 to September 2023.
- 4. A meter bearing no. LW013229 does exist in the premises.

He therefore requested before the Forum to do the needful as deemed fit in this regard.

The Forum after going through the available documents placed before it, observed that;

1. The CD of the premises is 01 KW of domestic load.

2. The transformer meant for the Soubhagya consumers was not charged till September'2023 although the service connection was there from dt.05.11.2018.
