#### HISTORY OF THE CASE

The Complainant is a LT-Dom. consumer availing a CD of 2 KW. He has disputed that the OP has not revised the bill as per direction of learned GRF in Case no. 986/2023. He has submitted his grievances for revision of bill. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

# PROCEEDING OF HEARING DATED: 16.03.2024

Both the parties did not appear before the Forum on the date of hearing for which the date has adjourned to 19<sup>th</sup> Mar. 2023 at Cherupali GRF Camp court. Accordingly, both the parties were intimated through official letter as well as telephonic call and both the parties were given consent to appear on 19<sup>th</sup> Mar. 2023 hearing date.

# PROCEEDING OF HEARING DATED: 19.03.2024

The complainant did not appear on this date neither has submitted any written request for deferment of date. Hence, the Forum is of the opinion to conduct the hearing.

## SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under Cherupali section of Binka Sub-division. The consumer represented that OP has not revised the bill as per GRF order in Case no. 986/2023. The complainant requested before the Forum to issue direction for compliance of GRF order.

### SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with billing ledger. On defence, he intimated that the consumer is a LT-Domestic consumer availing power supply since Sep.-2011. The dispute raised by the complainant is not based on the facts. As per GRF order in Case no. 986/2023, the OP has revised the bill and withdrawn ₹. 14,056.96p in the bill of Nov-2023.

Considering the above, the OP requested before the Forum to reject the petition of the complainant and pass order as deemed fit.

#### FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom. consumer with a CD of 2 KW. The consumer has availed power supply since 02<sup>nd</sup> Nov. 2011 and the arrear outstanding upto Feb.-2024 is ₹. 1,17,345.82p. As complained by the complainant and submission of OP, it is observed by the Forum that,

- 1. Earlier, the complainant was filed a case before GRF-Balangir which was registered as Case no. 986/2023. After hearing, the Forum was issued order and directed to revise the bill. Accordingly, the OP has revised the bill in Nov-2023 and withdrawn ₹. 14,056.96p but subsequently, the complainant has not paid the revised arrear amount for which the matter is pending at the end of the complainant.
- 2. The complainant has not paid the monthly bill regularly for which the arrear has accumulated to ₹. 1,17,345.82p upto Feb.-2024.
- 3. The OP has submitted that as the disputed billing period has already revised and not required for further revision.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

The OP has complied the Order of GRF in Case no. 986/2023 and withdrawn ₹. 14,056.23p and effected in the bill of Nov.-2023. Hence, the petition of the petitioner is hereby rejected.

Case is disposed off accordingly.
