ORDER (Dt.30.03.2024)

During hearing on dt.21.03.2024 the Complainant Sri Sukru Meher did not appear before the Forum whereas Sri Chinmaya Kumar Ratha, OAG-II appeared as authorised representative of opposite party.

The Complainant bearing consumer no. 915102020300 in his written petition disputed the abnormal billing trend resulting a huge arrear of his account due to defective status of the meter. He therefore requested before the Forum to revise the bill and reduce the arrear accordingly.

The opposite party on the other hand submitted a billing abstract pertaining to the period from April-May'2009 to February'2024 with a PVR dt.19.03.2024 having being enclosed with a written version which reveals that;

1. Irregularities are noticed against the meter no. WCG0639 during April-May'2020 to September'2020 having abnormal consumption of 1288, 3369 and 2740 units.

2. He has revised the wrong and abnormal bills after a review done in his level where an amount of Rs.4851.97 is to be credited the consumer's account.

3. The status of the existing meter bearing no. LW497374 is reported to be ok with CMR 5867 Kwh (as per PVR).

He also requested the Forum to do the needful in this regard as deemed fit.

Keeping the above facts in view the Forum observed that;

1. The meter bearing no. WCG00639 has recorded abnormal consumption of 1288, 3369 and 2740 units during the period May, June & July'2020 respectively. The meter has been therefore declared defective.

2. A new meter is seen to have been replaced having Sl. No. LW497374 which is in ok status with CMR 2567 as on dt.19.03.2024.

3. The opposite party has revised the wrong bills with probable sundry credit of Rs.4851.97.

Basing on above observations, Forum passes the following direction as per Regulation of OERC Distribution (Conditions of Supply) Code 2019.

The opposite party is directed to carry out and finalise the revision process on proposed withdrawal of Rs.4851.97 which must be reflected in the next bill.

month after receipt of GRF order otherwise it will be treated as non-compliance.
