HISTORY OF THE CASE

The Complainant is a LT-Dom. consumer availing a CD of 2.2 KW. He has disputed the average bill raised from Oct.-2021 to Oct.-2022 due to meter defective. He has submitted his grievances for revision of bill. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

PROCEEDING OF HEARING DATED : 20.03.2024

SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under ESO-III section of Patnagarh Sub-division. The consumer represented that he was served with average bills from Oct.-2021 to Oct.-2022 due to meter defective. For such, the arrear was accumulated to ₹. 7,152.70p upto Feb.-2024. The complainant raised dispute against the said period and requested before the Forum for suitable revision of the bill.

SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum without relevant record. On defence, he intimated that the consumer is a LT-Dom. consumer availing power supply since Nov-2001. The billing dispute raised by the complainant for the average billing from Oct-2021 to Oct-2022 is due to meter defective for that period. A new meter with sl. no. TW02000673 has been installed on 07th Jun. 2022 but due to protocol delay, it has been reflected in Nov-2022 with CMR : 557, thereafter actual billing is going on. As the above-stated period bill has not revised, it needs bill revision.

Considering the above, the OP requested before the Forum for revision of previous disputed bills and pass order as deemed fit.

FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom. consumer with a CD of 2.2 KW. The consumer has availed power supply since 20th Nov. 2001 and the arrear outstanding upto Feb-2024 is ₹. 7,152.70p. As complained by the complainant and submission of OP, it is observed by the Forum that,

1. Due to meter defective, the consumer was served with average bills from Oct-2021 to Oct-2022 resulting accumulation of arrear outstanding.
2. A new meter has been installed by OP with meter no.TW02000673 on 07th Jun. 2022 but due to delay in updation of meter protocol data, the KWH reading has been captured in Nov-2022 with CMR : 557. Accordingly, delay meter updation revision has been done in Oct.-2022 bill with credit of ₹. 1,834.12p.
3. The OP has submitted that as the disputed billing period has not yet been revised, it needs bill revision as per consumption of new meter.
4. On scrutiny of the documents, it is observed by the Forum that the bills raised during meter defective period needs bill revision under CI-155 & 157 of OERC Regulation 2019 to redress the consumer grievances.


In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.


1. The energy bills raised to the consumer from Oct.-2021 to May-2022 are to be revised as per succeeding six months average consumption of new meter by considering IMR: 0 (07.06.2022) & FMR: 661 (Dec-2022) under CI-155 & 157 of OERC Regulation 2019.
2. DPS is to be levied as per OERC Regulation.
3. All sundries and adjustments are to be considered during the above revision period.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
