## Complaint Case No. BGR/61/2024

ORDER (Dt.28.03.2024)

During on dt.16.03.2024 the Complainant Sri Danda Bagarty did not appear before the Forum whereas Sri Kailash Chandra Swain, DM (F&C), TPWODL, TED, Titilagarh appeared as authorised representative of opposite party.

The Complainant bearing consumer no. 912001031729 in his written petition during a camp held at 'Belgaon' under Saintala Sub-Division on dt.18.01.2024 stated that an abnormal high billing has been raised for a new meter was installed during January'2023 since earlier no meter was provided in the premises concerned. He however requested the Forum to sortout his grievance by way of a suitable bill revision.

On the other hand the opposite party submitted a billing abstract concerning to the period from April'2018 to January'2024 along with a PVR supported by a written version dt.12.02.2024 which reveals that;

- 1. The CD of the consumer is of 7.5 KW under Irrigation category.
- 2. As per FG database, the consumer was being billed under provisional and average basis since the date of power supply as there was no meter installed in the consumer's premises.
- 3. A new smart meter bearing no. 10052716 has been installed on dt.21.10.2023 with CMR of 1303 Kwh but with a billing of 13304 Kwh having final meter reading of the old meter of 12130 units.
- 4. As per PVR dt.12.02.2024 the existing meter is with ok status having CMR 4201 Kwh.

The Forum after going through the available documents placed before it, observed that:

1. Provisional bills prior to September-October'2023 do not appear to have been adjusted due to change of meter.

- 2. The CMR of the old meter is seen to be 12130 units where there was no meter in the premises.
- 3. Previous bills from the date of power supply to October'2023 is found to be erroneous.

The Forum therefore advised the opposite party for revision of bills who initiated it instantly on spot as per departmental guidelines. The calculated withdrawal amount is assessed to be Rs.18596.69ps out of the closing balance of Rs.22847.43ps. The net recoverable amount stands for Rs.4250.74ps.

Basing on above observations, Forum passes the following direction as per Regulation of OERC Distribution (Conditions of Supply) Code 2019.

The Forum directed the opposite party to proceed with the revision and further directed to finalise it immediately to be reflected in the bill of March'2024.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one

month after receipt of GRF order otherwise it will be treated as non-compliance.
