**ORDER**  
**(Dt.11.06.2024)**

**HISTORY OF THE CASE**

The Complainant is a LT-Dom. consumer availing a CD of 2 KW. He has disputed the inflated bill raised in Jan.-2019 with 1450 units. He has submitted his grievances for revision of bill. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

**PROCEEDING OF HEARING DATED : 05.06.2024**

**SUBMISSION OF COMPLAINANT DURING HEARING**

The complainant is a consumer under ESO-Saintala Section of Saintala Sub-division. The consumer represented that he was served with inflated bill in Jan-2019 with 1450 units. For that, the arrear was accumulated to ₹. 9,568.04p upto May-2024. The complainant raised dispute against the said period and requested before the Forum for suitable revision of the bill.

**SUBMISSION OF OPPOSITE PARTY DURING HEARING**

The OP appeared before the Forum with relevant documents. On defence, he intimated that the consumer is a LT-Domestic consumer availing power supply since Jun.-2014. The billing dispute raised by the complainant for the inflated billing done in the month of Jan-2019 with 1450 units is genuine. This has happened due to suppressed meter reading done by concerned meter to prevent actual billing in the previous months. As the above-stated period bill has not been revised, it needs bill revision.

Considering the above, the OP requested before the Forum for revision of previous disputed bills and pass order as deemed fit.

## FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom. consumer with a CD of 2 KW. The consumer has availed power supply since 01<sup>st</sup> Jun. 2014 and the arrear outstanding upto May-2024 is ₹. 9,568.04p. As complained by the complainant and submission of OP, it is observed by the Forum that,

1. Due to suppressed meter reading by the concerned meter reader in the preceding months, the consumer was billed less units than his actual consumption. This has been identified during Jan-2019 billing and the unbilled units of 1450 units has been billed in Jan-2019. Due to such bill, the arrear amount has accumulated.
2. The said meter with sl. No. 5869819 was installed since the date of power supply i.e. 01<sup>st</sup> Jun. 2014 and in operation till 24<sup>th</sup> Sep. 2023. A new meter with sl. No. TPWODL1160751 has been installed on 28<sup>th</sup> Sep. 2023 and continuing till date.
3. The complainant has not paid the monthly bill regularly for which the arrear has accumulated to ₹. 9,568.04p upto May-2024.
4. During the course of hearing, the OP has agreed with the billing complaints and initiated the bill revision process on the spot observing departmental guidelines. Accordingly, the monthly bill has recasted with the consumption and a net amount of ₹. 3,966.97p is to be withdrawn from the arrear outstanding.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

The OP has recasted the energy bill of Jan-2019 and the petitioner was convinced with the proposed withdrawal amount of ₹. 3,966.97p. Hence, the Forum directed the OP to carry-out the revision proposal which must be reflected in the next bill.

Case is disposed off accordingly.
