HISTORY OF THE CASE

The Complainant is a LT-Dom. consumer availing a CD of 3 KW. He has disputed the additional bill of 1090 units raised in Jul-2023. He has submitted his grievances for revision of bill. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

PROCEEDING OF HEARING DATED : 10.07.2024


SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under Kantabanji Section of Kantabanji Sub-division. The consumer represented that he was served with erroneous bill of 1090 units in Jul-2023 bill. For that, the arrear has accumulated to ₹ 8,001.00p upto Jun.-2024. The complainant raised dispute against the said period and requested before the Forum for suitable revision of the bill.

SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with relevant record. On defence, he intimated that the consumer is a LT-Dom. consumer availing power supply since Sep.-2015. The billing dispute raised by the complainant for the erroneous bill of 1090 units in Jul-2023 units is a genuine dispute due to suppressed meter reading done by concerned meter to prevent actual billing in the previous months. As the above-stated period bill has not been revised, it needs bill revision.

Considering the above, the OP requested before the Forum for revision of previous disputed bills and pass order as deemed fit.

FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom. consumer with a CD of 3 KW. The consumer has availed power supply since 16th Sep. 2015 and the arrear outstanding upto Jun.-2024 is ₹. 8,001.00p. As complained by the complainant and submission of OP, it is observed by the Forum that,

1. The complainant has disputed about the inflated & erroneous bill of 1090 units raised in the bill of Jul-2023 served in Aug-2023. The OP submitted that the said dispute is a genuine dispute due to suppressed meter reading.

The Forum observed that this is a case suppressed meter reading that due to suppressed meter reading by the concerned meter reader in the preceding months, the consumer was billed less units than his actual consumption. This has been identified during Jul.-2023 billing and the unbilled units has been billed in Jul.-2023. Due to such bill, the arrear amount has accumulated.


2. From the billing ledger, it is found that the said meter having sl. No. WCV26477 has been installed since 16th Sep. 2015 and as per meter reading of Jul-2023, the CMR is 16610.
3. During the course of hearing, the OP has agreed with the billing complaints and initiated the bill revision process on the spot observing departmental guidelines. Accordingly, the monthly bill has been recasted with the consumption and a net amount of ₹. 6,368.22p is to be withdrawn from the arrear outstanding.


In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

The OP has recasted the bill and the petitioner was convinced with the proposed withdrawal amount of ₹. 6,368.22p. Hence, the Forum directed the OP to carry-out the revision proposal which must be reflected in the next bill.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
