ORDER (Dt.24.06.2024)

During hearing on dt.20.06.2024 the Complainant's representative Sri Mrunmaya Pathrimali appeared before the Forum whereas Smt. Sita Rani Seth, Jr. Accountant, Electrical Sub-Division, No. II, TPWODL, Bolangir appeared as authorised representative of opposite party.

The Complainant bearing consumer no. 911212160035 in his written petition stated that exorbitant bills on abnormal unit consumption have been done during the period from April'2023 to August'2023. Subsequently a new meter has been replaced during August-September'2023. He therefore requested before the Forum to revise the bill and reduce the arrear. He further stated that he has cleared up all the previous arrears through OTS during April'2023.

On the other hand the opposite party submitted a billing abstract pertaining to the period from February-March'2001 to May'2024 having enclosed with a PVR dt.05.06.2024 and a written version. The documents so submitted reveals that;

- 1. The meter bearing Sl. No. 1930511 existing since 2006 has been replaced by a new one bearing no. TWSP51025992 on dt.08.09.2023.
- 2. The CD of the premises is 1.5 KW under domestic load.
- 3. Abnormal consumption is observed from April'2023 to August'2023 with 800, 1020, 1008 & 907 units respectively indicating the meter status being defective as the said meter has been replaced on dt.08.09.2023 with a remark that "meter defective".

He also requested before the Forum to do the needful as deemed fit in this regard.

The Forum after going through all the relevant records placed before it, observed that;

a. The CD of the premises is 1.5 KW under domestic load.

b. The monthly consumption from April'2023 to August'2023 appears to be abnormal with high consumption which is supported with meter replacement report as "meter defective".

c. The above meter bearing defective has been replaced by a new one with Sl. No. TWSP51025992 on dt.08.09.2023.

d. The Forum is of the opinion for revision of the bills from April'2023 to August'2023 from the monthly average consumption of the new meter from subsequent six months.

Basing on above observations, Forum passes the following direction as per Regulation of OERC Distribution (Conditions of Supply) Code 2019.

The bills form April'2023 to August'2023 are to be revised after obtaining monthly average consumption of subsequent six month of the new meter by taking IMR '0' (IMR on dt.08.09.2022) and FMR '1509' (CMR of April'2024).

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one

nonth after receipt of GRF order otherwise it will be treated as non-compliance.
