The matter being adjourned to facilitate respondent for submission of a calculation on the DPS charged on the withdrawal amount and existing over present claim against the complainant. Accordingly, the respondent has submitted the same under intimation to the complainant. Upon notice to appear before this forum on dt.0.705.2025 both the parties submitted their respective version. It appears from the version of the respondent that in case the case of complainant is considered by this forum the DPS charged on withdrawn amount will come to Rs.75,443.14 levied over earlier withdrawn amount of Rs.3,47,665.77. Besides this the respondent has also submitted the details of the consumer as on today including meter condition and billing abstract.

In response the complainant has also intimated this forum in writing that he is satisfied with the revision already made and also with the present proposed revision of DPS and as such requested for disposal of this case vide his version dt.08.05.2025.

Upon consideration of the matter in hand this forum is of opinion that while revising the bills earlier in compliance to the order dtd. 22.04.2024 of this forum passed in this case, the proportionate DPS should have been withdrawn. When there is no payable demand, then the claim of DPS thereon is not justified. However, it is felt that due to no specific direction on DPS such an omission has occasioned on the part of the respondent.

So, to ascertain the matter specifically this forum had directed the respondent to calculate the DPS claimed on the withdrawn amount. Now when the respondent has submitted the same and the complainant has expressed his satisfaction over the same there exist no more dispute between the parties. So, taking into account the submission by both the parties this case needs to be disposed of with the submission of a report to Hon'ble OERC, Bhubaneswar.

ORDER 13.05.2025

The re-casted statement on DPS is accepted, accordingly the respondent is directed to act upon the same and revise the EC bills within one month of this order i.e., from receipt of this order. The complainant at the same time is to clear the outstanding (if any) after the same without any delay.

The case is disposed of accordingly.
