GIST OF THE COMPLAINT:

The complainant consumer Sri Tirtha Bagarti, Repr. by Sri Jogindra Bagarti, AT-Dutta, Po-Salepali, Ps-M. Rampur, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at M. Rampur on dt. 20.12.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 4 KW having consumer no- 9030-0101-1822 under EE, KEED, Bhawanipatna.
- 2) As complained by the complainant excess that the average bills were served.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.


SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, KEED, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

1) PVR: 25/12/2024

2) Bill details from: 02/2001 to 11/2024

3) Date of supply: 01/01/1990



- 5) Connected Load 4 KW
- 6) Meter No TPU014047

7) Installed on: 26/03/2022 with IMR: "0"

8) CMR: 656 KwH as on 25/12/2024

9) The meter status: Ok

10) Facts of the complainant: Revision of bill

11) As written version submitted by EE, KEED, Bhawanipatna as follows:

• The consumer was billed as defective from 03/2020 to 02/2022 so we may revise the bill from 03/2020 to 02/2022 by taking 12 months of new meter installed i.e from 03/2022 to 03/2023 as IMR-0 KwH and FMR-700 KwH.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the consumer was billed as defective from 03/2020 to 02/2022 so we may revise the bill from 03/2020 to 02/2022 by taking 12 months of new meter installed i.e from 03/2022 to 03/2023 as IMR-0 KwH and FMR-700 KwH.
- As per database average bills were served due to without meter

ORDER 27.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

• To revise the bill from 03/2020 to 02/2022 by taking IMR "0" KwH on 03/2022 and FMR "700" KwH as on 03/2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>February-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
