### GIST OF THE COMPLAINT:

The complainant consumer Sri Sahadev Majhi, AT/P.O- Kantesir, Ps- Kesinga Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt.09.02.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ irrigation supply with CD of 2.50 KW having consumer no- 9030-0101-3249 under EE, KEED, Bhawanipatna.
- 2) As complained by the complainant his motor has been burnt for 2 years, still he was billed on the provisional basis.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

To withdraw the provisional bill was raised during motor burnt period.

# SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, KEED, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 9) Meter Status: OK
- 10) Facts of the complainant: There is no such scope of bill revision.
- 11) As written version submitted by EE, KEED, Bhawanipatna as follows:
  - The consumer was complained earlier and GRF order was issued vide order no. 150/2023. The bill also revised for an amount of Rs. 22,178.88 and deducted from his bill on dtd. 29.01.2024.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

The complainant reiterated for withdraw the provisional bill was raised during motor burnt period. The OP submitted that the consumer was complained earlier and GRF order was issued vide order no. 150/2023. The bill also revised for an amount of Rs. 22,178.88 and deducted from his bill on dtd. 29.01.2024.

## ORDER 22.04.2024
