# **GIST OF THE COMPLAINT:**

The complainant consumer Sri Bhimsen Bhoi, Repr. By Sri Ghanteswar Bhoi, At-Pipalpada, PO-Rupra, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at M. Narla on dt.15.02.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Dom supply with CD of 1.5 KW having consumer No- 9030-0101-2919 under EE KEED, Bhawanipatna.
- 2) As complained by the complainant the provisional/average bill was served from 04/2018 to 01/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.

#### SUBMISSION OF OPPOSITE PARTY IN BRIEF:

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- ➤ The complainant reiterated for revise of his provisional/average billing was served from 06/2014 to 01/2023. The OP submitted that the consumer was billed as defective from 04/2021 to 01/2023.
- As per billing database the provisional adjustment has been considered for the period 05/2022 to 02/2023.

# ORDER 18.04.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill from 05/2020 to 04/2022 by taking average consumption of from 03/2023 with IMR "15" KwH to 02/2024 with FMR "267" KwH on 02/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
