Borda on dt. 12.03.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation 2.5 supply with CD of 0.05 KW having consumer no- 9030-0101-2987 under EE, KEED, Bhawanipatna
- 2) As complained by the complainant that the average /Provisional bill were issued.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

#### **FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- · The complainant reiterated for excess billing.
- The OP stated that We may revise the bill from 12/2019 to 11/2021 by taking IMR 0 kwh on 12/2021 and FMR 791 kwh on 11/2022.
- As per billing database average / provisional bills were served though the meter was changed 31/12/2021.

## ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill from 12/2019 to 11/2021 by taking IMR "0" kwh on 12/2021 and FMR "791" kwh on 11/2022.

The case is disposed of accordingly.
