The complainant has given in writing and submitted during course of hearing at camp court in brief as follows:



## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

 The complainant reiterated for provisional billing. The OP submitted that in the consumer was billed provisional basis in various periods and the consumer getting bill from 04/2022 on actual basis and again on provisional basis up to 10/2023 after installation of new meter.

# ORDER 31.01.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

➤ To revise the bill from 09/2021 to 08/2023 by taking 1 year average consumption of new meter installed on 28.10.2023 (though the consumer is LT/Irrigation & Pumping and Agriculture category).

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
