

#### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Jagabandhu Rana repr. by Sri Angad Rana, At- Badapitamal, Po-Madanpur, Ps- M. Rampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Madanpur on dt. 06.03.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1.5 KW having consumer no- 9030-0101-3103 under EE, KEED, Bhawanipatna
- 2) As complained by the complainant that excess average bills were served.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that We may revise the bill from 06/2020 to 05/2022 by taking average of new meter installed i.e from 05/2022 to 06/2023 as IMR 0 kwh and FMR 610 kwh.
- As per billing database excess average bills were served.

## ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To revise the bill from 06/2020 to 05/2022 by taking one-year average consumption of meter installed on 05/2022 taking IMR "0" kwh on 05/2022 and FMR "610" kwh on 05/2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by April-25 the opposite party after compliance otherwise it will be treated as non-compliance.
