GIST OF THE COMPLAINT:

The complainant consumer Sri Brajamani Sahu, At-Talsagarpada, Po/Ps- M. Rampur, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at M. Rampur on dt. 19.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 1.5 KW having consumer no-9030-0101-3143 under EE, KEED, Bhawanipatna
- 2) As complained by the complainant to withdraw the bill amount during no power supply
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, KEED, Bhawanipatna) in its counter reply and course of hearing submitted as follows:



1) PVR: 04/10/2024

2) Bill details from: 12/2015 to 09/2024

3) Date of supply: 05/08/2015

4) Category: LT/Irriagation Pumping and Agriculture

5) Connected Load: 1.5 KW 6) Meter No - TPU024133

7) Installed on: 06/05/2022 with IMR: "0"

8) CMR: 10 KwH as on 04/10/2024

9) The meter status: Ok

10) Facts of the complainant: Revision of bill

As written version submitted by EE, KEED, Bhawanipatna as follows:

- As per the PVR given by the ESO, M. Rampur the point was not used since date of supply which was certified by OLIC department, Sarpanch and neighbours. So total bill may be withdrawn.
- So, the bill from 08/2015 to 01/2023 may be withdrawn as there was no power supply was given at that time.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as per the PVR given by the ESO, M. Rampur the point was not used since date of supply which was certified by OLIC department, Sarpanch and neighbours. So total bill may be withdrawn.
- So, the bill from 08/2015 to 01/2023 may be withdrawn as there was no power supply was given at that time.

ORDER 28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill amount excluding the fixed charges from 08/2015 to 09/2024, to close the account.
- If he wants to avail the power supply he has to deposit the appropriate amount.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
