#### GIST OF THE COMPLAINT:

The complainant consumer Sri Rahul Kumar Jain repr. by Sri Jayabhagawan Jain AT/Po-Kesinga, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 13.06.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 1.5 KW having consumer no- 9030-0101-3196 under EE, KEED, Bhawanipatna.
- 2) As complained by the complainant the provisional/average bill was served from 10/2015 to to 08/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.

#### SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, KEED, Bhawanipatna) in its counter reply and course of hearing submitted as follows:



- 1) PVR: 26/07/2024
- 2) Bill details from December 2015 to June 2024
- 3) Date of supply 20/10/2015
- 4) Category: LT/Irrigation Pumping and Agriculture
- 5) Connected Load 1.5 KW
- 6) Meter No TPU013377
- 7) Installed on 31/12/2021 with IMR: "0"
- 8) CMR: 1424 KwH as on 26/07/2024
- 9) The meter status OK
- 10) Facts of the complainant: Revision of abnormal bill
- 11) As written version submitted by EE, KEED, Bhawanipatna as follows:
  - As per the PVR given by the ESO Nunmath meter reading was 1424 KwH on 26/07/2024 and running OK.
  - The consumer billed as defective from 04/2021 to 05/2022.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that as per the PVR given by the ESO Nunmath meter reading was 1424 KwH on 26/07/2024 and running OK.
- The consumer bill as defective from 04/2021 to 05/2022.
- As per billing database the provisional/average was served from 10/2015 to 08/2022.

# ORDER 31.07.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill from 09/2020 to 08/2022 by taking average consumption of present meter (i.e. IMR "0" KwH on 01/2022 and FMR "461" KwH on dtd. 02/2023).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
