The complainant consumer Sri Ramakrishna Sarangi, Repr. by Sri Ranjit Kumar Sarangi, AT- Sukunabhata, Po- Kasrupada, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 16.12.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 1.5 KW having consumer no- 9030-0101-3713 under EE, KEED, Bhawanipatna.
- 2) As complained by the complainant that the provisional bill was served from date of power supply.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional bill.

## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that, as the consumer was billed from 09/2022 to 11/2023.
- As per billing database the provisional bill was served from 05/2018 to 08/2022 & the bill was served in average basis from 09/2022 to 07/2023 due to defective meter.

# ORDER 06.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from 05/2018 to 08/2022 with IMR "0" KwH on 05/2018 and FMR "4566" KwH on 08/2022.

➤ To revise the bill from 09/2022 to 11/2023 by taking one-year average consumption of present meter (i.e. IMR "0" KwH on 11/2023 and FMR "3700" KwH on 10/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>January-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
