GIST OF THE COMPLAINT:

The complainant consumer Sri Bikram Keshari Padhan, Repr. by Sri Ashok Padhan, At/Po- Ghodabandh, Ps-Narla, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 06.07.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 4 KW having consumer no- 9030-0101-4045 under EE, KEED, Bhawanipatna.
- 2) As complained by the complainant provisional/average bill was raised from 05/2019 to 08/2021.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, KEED, Bhawanipatna) in its counter reply and course of hearing submitted as follows:



- 1) PVR: 13/08/2024
- 2) Bill details from August 2019 to June 2024
- 3) Date of supply 27/05/2018
- 4) Category: LT/Irrigation Pumping and Agriculture
- 5) Connected Load 4 KW
- 6) Meter No 10045954
- 7) Installed on 01/08/2024 with IMR: "0"
- 8) CMR: 459 KWH as on 13/08/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill.
- 11) As written version submitted by EE, KEED, Bhawanipatna as follows:
 - As per the PVR given by the ESO Narla the meter reading was 459 KWH on 23/07/2024 and Running OK, the consumer was billed as defective from 04/2021 to 05/2022.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that as per the PVR given by the ESO Narla the meter reading was 459 KWH on 23/07/2024 and Running OK, the consumer was billed as defective from 04/2021 to 05/2022.
- As per billing database the provisional bill was raised from 08/2019 to 08/2021 and 09/2021 to 06/2024 billed in "X" code.

ORDER 31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To revise the bill from 11/2020 to 08/2021 by taking one-year average consumption of new meter installed on 01/08/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
