GIST OF THE COMPLAINT:

The complainant consumer Sri Prakash Chandra Bhoi, At/Po- Borda, Ps- Kesinga, Dis- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 21.02.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 1.5 KW having consumer no- 9030-0101-4517 under EE, KEED, Bhawanipatria
- 2) As complained by the complainant that average bill was charged during the no supply period.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, KEED, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

2) Bill details from: 05/2020 to 01/2025

3) Date of supply: 28/11/2019



4) Category: LT/Irrigation Pumping and Agriculture

9) The meter status: OK

10) Facts of the complainant: Revision of bill

- 11) As written version submitted by EE, KEED, Bhawanipatna as follows:
 - As per the PVR given by the AOC, Borda the meter is found OK. The consumer was availed power supply from 02/2022, before that there is no such power supply at the consumer premises.
 - So, we may withdraw the total bill generated from 11/2019 to 01/2022.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as per the PVR given by the AOC, Borda the meter is found OK. The consumer was availed power supply from 02/2022, before that there is no such power supply at the consumer premises.
- So, we may withdraw the total bill generated from 11/20219 to 01/2022.
- As per billing database average bills were served from 05/2020 to 02/2022, the bills were served on actual meter reading after an installation of meter on 16/02/2022.

ORDER 28.02.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To withdraw the bill from 11/2019 to 01/2022 as the consumer was not availed the power supply.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by March-25 the opposite party after compliance otherwise it will be treated as non-compliance.
