GIST OF THE COMPLAINT:

The complainant consumer Sri Rupadhar Majhi, At- Dendoguda, Po- Saria, Ps- Narla, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 17.03.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 5 KW having consumer no- **9030-0101-5137** under EE, KEED, Bhawanipatna
- 2) As complained by the complainant that excess units was billed in the month of 05/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, KEED, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 19/03/2025
- 2) Bill details from: 02/2022to 02/2025
- 3) Date of supply: 13/01/2022

- 4) Category: LT/Irrigation Pumping and Agriculture
5) Connected Load 5 KW
6) Meter No –10026964
7) Installed on: 13/11/2022 with IMR "0"
8) CMR: 3115 KWH on 19/03/2025
9) The meter status: OK
10) Facts of the complainant: Revision of bill
11) As written version submitted by EE, KEED, Bhawanipatna as follows:
- We may recast the bill from 01/2022 to 10/2022 by taking IMR 0 kwh and FMR 788 kwh.



FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that We may recast the bill from 01/2022 to 10/2022 by taking IMR 0 kwh and FMR 788 kwh.
- As seen from the database the meter having Sl. No. 10026964 was installed in the month of 11/2022 and charge with meter rent of Rs. 1000/- per month which was wrong being a 3 ph. whole current meter Discom corrected the meter rent to Rs. 150/- per month in the month of 10/2023 so the wrong meter rent charge from 11/2022 to 09/2023 to be recalculated as Rs. 150/- per month instead of Rs. 1000/- per month.

ORDER

29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

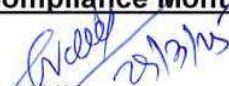
The OP is directed as follows:


- To recalculate the meter rent Rs. 150/- per month instead of Rs. 1000/- from 11/2022 to 09/2023 as it is 3 ph. whole current meter.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by April-25 the opposite party after compliance otherwise it will be treated as non-compliance.
