### GIST OF THE COMPLAINT:

The complainant consumer Sri Rajman Majhi AT- Dendoguda, P.O- Saria, Ps- Narla, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 22.03.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ irrigation supply with CD of 5 KW having consumer no- **9030-0101-5139** under EE, KEED, Bhawanipatna.
- 2) As complained by the complainant the provisional bill was raised from date of power supply to 10/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional bill.

## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings

 The complainant reiterated for provisional billing. The OP submitted that the consumer was billed as provisional from date of power supply to 10/2022.

## ORDER 30.05.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To revise the bill from 02/2022 to 10/2022 by taking average consumption of present meter (i.e. IMR "0" KwH on 11/2022 and FMR "604" KwH on 12/2023).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
