## **GIST OF THE COMPLAINT:**

The complainant consumer Sri Tankadhar Parida Repr. by Repr. by Sri Ujjal Kumar Parida, At-Paikasadel, Po-Turchi, Ps- M. Rampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at M. Rampur on dt. 06.06.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 2.50 KW having consumer no- 9030-0101-3335 under EE, KEED, Bhawanipatna .
- 2) As complained by the complainant that the bill was raised during disconnection period.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the excess bill.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per the PVR given by the ESO, M. Rampur there was no power supply from 20/07/2016 to 09/03/2022.
- As per billing database the provisional/average bill was raised from 07/2016 to 02/2022.

# ORDER

#### 26.06.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

➤ To withdraw the bill from 07/2016 to 02/2022. As the consumer has not availed the power supply during that period.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>July-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
