GIST OF THE COMPLAINT:

The complainant consumer The President of Sriram Pani Panchayat, Repr. by Sri Khageswar Patra, AT- Upher, Po- Sergarh, Ps- Narla, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at M. Rampur on dt. 20.12.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 7.50 KW having consumer no- 9030-0102-2716 under EE, KEED, Bhawanipatna.
- 2) As complained by the complainant that the provisional/average bill was served from 08/2011 to 10/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, KEED, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from: 10/2007 to 11/2024



3) Date of supply: 09/08/2011

4) Category: LT/Irrigation Pumping and Agriculture

5) Connected Load 7.50 KW

9) The meter status: Ok

10) Facts of the complainant: Revision of bill

4) As written version submitted by EE, KEED, Bhawanipatna as follows:

As the consumer was billed as defective from 11/2020 to 10/2022, we may revise
the bill from 11/2020 to 10/2022 by taking average of 21 months of new meter
installed i.e. 11/2022 to 07/2024 as IMR "0" kwh and FMR "22344" kwh.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as the consumer was billed as defective from 11/2020 to 10/2022.
- As per billing database the provisional/average bill was served from 08/2011 to 10/2022.

ORDER 06.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

 To revise the bill from 11/2020 to 10/2022 by taking average of present meter from 11/2022 to 12/2024 (i.e. IMR "5522" KwH on 11/2022 and FMR "27861" KwH on 12/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>January-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
