#### GIST OF THE COMPLAINT:

The complainant consumer Laxminarayan Pani Panchayat, Repr. by Sri Ramachandra Padhi, At/Po- Narla Road, Ps- Narla, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 09.08.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 9.50 KW having consumer no- 9030-0102-2742 under EE, KEED, Bhawanipatna.
- 2) The President Sri Laxminarayan Pani Panchayat has complained that the motor was damaged due to flood on 14/08/2016 to 16/08/2016 on 04/09/2016, which was received in the section office.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

To revise the excess bill.

#### SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, KEED, Bhawanipatna.) in its counter reply and course of hearing submitted as follows:

- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE, KEED, Bhawanipatna as follows:
  - As per the PVR submitted by the power supply was disconnected from 09/2018 to 09/2022 due to flood.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant has intimated to the JE Narla regarding damage of LI point due to continues rain from 14/08/2016 to 16/08/2016 on 04/09/2016.
- The OP stated that as per the PVR submitted by the power supply was disconnected from 09/2018 to 09/2022 due to flood.

## **ORDER** 30.09.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To withdraw the bill amount excluding the fixed charges from 09/2018 to 09/2022 of LI point due to damage of flood.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
