## GIST OF THE COMPLAINT:

The complainant consumer The President Badachiching Pani Panchayat, Repr. by Sri Rajaram Sahu AT- Badachiching, P.O- Santpur, Ps- Narla, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Chhatikuda on dt.07.03.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ irrigation supply with CD of 11.50 KW having consumer no- 9030-0102-2781 under EE, KEED, Bhawanipatna.
- 2) As complained by the complainant the bill was raised during transformer burnt period.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the average, revise the excess bill.



# SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, KEED, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 1) PVR dtd. 27.03.2024
- 2) Bill details from September 2012 to March 2024
- 3) Date of supply 07.09.2012
- 4) Category: LT/ Irrigation Pumping and agriculture
- 5) Connected Load 11.50 KW
- 6) Meter No- 10021533
- 7) Installed on: 01.11.2023 with IMR: "0"
- 8) CMR: 6570 KwH as on 27.03.2024
- 9) Meter Status: Ok
- 10) Facts of the complainant: To revise the bill
- 11) As written version submitted by EE, KEED, Bhawanipatna as follows:
  - The consumer was billed as defective from 04/2021 to 06/2022.
  - As reported by the concerned ESO, the transformer was burnt from 04/2019 to 07/2022

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that the consumer was billed as defective from 04/2021 to 06/2022. And, As reported by the concerned ESO, the transformer was burnt from 04/2019 to 07/2022.
- As per billing database it appears that bill revision towards defective period assessment from 09/2012 to 12/2020 and 01/2021 to 05/2022 has done, effect on dtd. 24.03.2024 & 01.01.2024 respectively.
- As per billing database it appears that provisional/average bill was served from date of power supply, i.e. 09/2012 to 05/2022.

# ORDER 14.05.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- ➤ To withdraw the bill from 04/2019 to 05/2022 only fix charge to be claim to the complainant as transformer was burnt.
- To revise the bill from 04/2017 to 03/2019 by taking average 1-year consumption of present meter installed on 01.11.2023.

To withdraw the earlier bill revision towards defective period assessment, effect on dtd. 24.03.2024 & 01.01.2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
