GIST OF THE COMPLAINT:

The complainant consumer The President of Dangar Budha Pani Panchayat, Repr. by Sri Bhadra Harijan, AT- Gobardhanpur Po- Panimunda, Ps- Narla, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 09.08.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 7.50 KW having consumer no- 9030-0102-2787 under EE, KEED, Bhawanipatna
- 2) As complained by the complainant that the provisional/defective bill was served from 01/2013 to 01/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

To revise the provisional/average bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, KEED, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 23/09/2024
- 2) Bill details from March 2013 to January 2024



- 4) Category: LT/Irrigation Pumping and agriculture
- 5) Connected Load 7.50 KW
- 6) Meter No TPU28865
- 7) Installed on 12/01/2022 with IMR: 0
- 8) CMR: 31740 KwH as on 23/09/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE, KEED, Bhawanipatna as follows:
 - As the consumer was billed as provisional / defective from the date power supply.
 - The defective bill may be revised by taking average of one year of new meter installed i.e. 12/01/2022.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that as the consumer was billed as provisional / defective from the date power supply.
- As per billing database the provisional/defective bill was served from 01/2013 to 01/2024.
- Bill revision was done from 01/2021 to 02/2023 on 31.03.2023 with credit sundry of Rs. 27760.32.

ORDER 30.09.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To revise the bill from 01/2019 to 12/2020 by taking average consumption of present meter was installed on 12/01/2022 (i.e. IMR "0" KwH on 01/2022 and FMR "31740" KwH on 08/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
