GIST OF THE COMPLAINT:

The complainant consumer The President Sri Krishna Pani Panchayat, Repr. by Sri Mohan Suna AT/Po- M. Rampur, Ps- M. Rampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at M. Rampur on dt. 20.12.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 7.50 KW having consumer no- **9030-0102-2937** under EE, KEED, Bhawanipatna.
- 2) As complained by the complainant that the provisional/average bill was served from 04/2016 to 08/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, KEED, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 27/12/2024
- 2) Bill details from: 04/2016 to 03/2022



- 3) Date of supply: 05/04/2016
- 4) Category: LT/Irrigation Pumping and Agriculture
- 5) Connected Load 7.50 KW
- 6) Meter No – 10006088
- 7) Installed on: 05/10/2022 with IMR: "0"
- 8) CMR: 12941 Kwh as on 27/12/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
 - 4) As written version submitted by EE, KEED, Bhawanipatna as follows:
 - The consumer was billed as defective from 04/2016 to 09/2022, so we may revise the bill from 10/2020 to 09/2022 by taking average of 12 months of new meter installed i.e. from 09/2022 to 08/2023 as IMR 0 kwh and FMR 3670.26 kwh.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the consumer was billed as defective from 04/2016 to 09/2022.
- As per billing database the bill was served provisional/average basis from 04/2016 to 09/2022.

ORDER

06.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from 10/2020 to 09/2022 by taking 12 months average consumption of present meter (i.e. IMR "0" Kwh on 10/2022 and FMR "3670" Kwh on 08/2023).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by January-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
