GIST OF THE COMPLAINT:

The complainant consumer The President Vivekananda Pani Panchayat, Repr. by Sri Dharmaraj Patra, At- Sirigund, Po-Domkarlakuta, Ps- M. Rampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 18.01.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 9.50 KW having consumer no- 9030-0102-3006 under EE, KEED, Bhawanipatna.
- 2) As complained by the complainant that abnormal provisional / average bill was served from 01/2017 to 10/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:


To revise the excess bill.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per the PVR given by the AoT Madanpur the old meter was found disconnected.
- As per billing database provisional/average bill was served from 01/2017 to due to 10/2022.

ORDER 31.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

➤ To revise the bill from 11/2020 to 10/2022 by taking average consumption of present meter (i.e. IMR "0" KwH on 10/2022 and FMR "21472" KwH on 08/2024) excluding the disconnection period.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>February-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
