GIST OF THE COMPLAINT:

The complainant consumer The President Sri Ganesh Pani Panchayat, Repr. by Sri Kuna Jal, AT- Dutta, Po- Salepali, Ps- M. Rampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at M. Rampur on dt. 20.12.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 7.5 KW having consumer no- 9030-0102-3052 under EE, KEED, Bhawanipatna.
- 2) As complained by the complainant that excess provisional/average bill were served.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, KEED, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

1) PVR: 25/12/2024

2) Bill details from: 08/2017 to 11/2024

3) Date of supply: 09/08/2017

4) Category: LT/Irrigation Pumping and Agriculture



- 5) Connected Load 7.5 KW
- 6) Meter No 10024324
- 7) Installed on: 01/03/2023 with IMR: "0"
- 8) CMR: 5926 KwH as on 25/12/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE, KEED, Bhawanipatna as follows:
 - The consumer was billed as defective from 03/2021 to 02/2023 so we may revise bill from 03/2021 to 02/2023 by taking average of 17 months of new meter installed i.e from 03/2023 to 07/2024 as IMR-0 KwH and FMR-5361 KwH.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the consumer was billed as defective from 03/2021 to 02/2023 so we may revise bill from 03/2021 to 02/2023 by taking average of 17 months of new meter installed i.e from 03/2023 to 07/2024 as IMR-0 KwH and FMR-5361 KwH.
- As per database the excess/average bills were served

ORDER 27.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill from 03/2020 to 02/2022 taking IMR "0" KwH on 25.03.2022 and FMR "9883" KwH on 28.02.2023

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by February-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
