

SUBMISSION OF COMPLAINANT DURING HEARING:

The complainant reiterated his complaint regarding abnormal billing done from 11/2020 to 10/2022. He requested to revise wrong billing as per the consumption of present meter.

OBSERVATIONS OF THE FORUM

From the database and statement as submitted by EE, KEED, the Forum observed that the bills were raised with abnormally high units for the period 11/2020 to 10/2022. The consumer was also aggrieved for the wrong meter rent charged.

ORDER 01.01.2024

Based on the above observations, the Forum passes the following order as per regulations 155 of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

1. Average/provisional bills during the period 11/2020 to 10/2022 is to revise on the basis of average consumption of the present meter taking IMR as "0" on October-2022 and FMR as "12139" December-2023.

Case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
