GIST OF THE COMPLAINT:

The complainant consumer President Maa Arnapurna Pani Panchayat, Repr. by Sri Tribhusan Podh, AT- Dendoguda - 2, Po- Laitara, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 16.12.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 1 KW having consumer no- 9030-0102-3391 under EE, KEED, Bhawanipatna.
- 2) As complained by the complainant that the bill was served on the PWW category instead of LI category.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill & change the billing category.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, KEED, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 21/12/2024
- 2) Bill details from: 04/2021 to 11/2024



- 4) Category: LT/PWW
- 5) Connected Load 8 KW
- 6) Meter No 10026860
- 7) Installed on: 06.11.2022 with IMR: "0"
- 8) CMR: 23647 KwH as on 21/12/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE, KEED, Bhawanipatna as follows:
 - As the consumer PVR given by the ESO, Utkela the consumer is using power supply under LI category, but billing was done under PWW category. So, I pray to the Hon'ble GRF to change the category from PWW to LI category from the date of power supply and order to revise the bill.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that, as the consumer PVR given by the ESO, Utkela the consumer is using power supply under LI category, but billing was done under PWW category from the date of power supply.
- As per billing database the bill was served in PWW category, and too many revisions were taken in place from 06/2023 to 11/2024.

ORDER 06.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from 10/2022 to 11/2024 in LT/ LI category instead of LT/PWW category.
- To serve the bill in LT/LI category from 12/2024 onwards.
- ➤ To withdraw the earlier bill revisions was take in place from 06/2023 to 11/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>February-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
