GIST OF THE COMPLAINT:

The complainant consumer Sri Laxman Dora, At-Kesinga, Po- Kesinga, Ps- Kesinga, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Dharamgarh on dt. 19.11.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ GP supply with CD of 2 KW having consumer no- 9033-0101-0013 under SDO Elect. Kesinga.
- 2) As complained by the complainant that the bill was raised in LT/GP category instead of LT/ Domestic. And the provisional bill was raised from 07/2019 to 01/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

To revise the bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 12/11/2024
- 2) Bill details from: 02/2001 to 10/2024
- 3) Date of supply: 01/01/1990
- 4) Category: LT/GP
- 5) Connected Load 2 KW
- 6) Meter No TWSP51160963

10) Facts of the complainant: Revision of bill

11) As written version submitted by SDO Elect. Kesinga as follows:

• Excess billing in the month of 04/2024.

As per PVR submitted by officer com. And JE Kesinga on dated 12/11/2024, the
consumer was availing power supply for DOMESTIC purpose only but consumer
getting bill in commercial category, Line was disconnected in field from 08/2019 to
01/2024, but entered in FG for bill stop on dtd. 21.11.2022 and reconnected after
deposit of reconnection fee of Rs. 472/- with MR no. 4475120852401020001 on
dtd. 08.05.2024.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Excess billing in the month of 04/2024.
- As per PVR submitted by officer com. And JE Kesinga on dated 12/11/2024, the
 consumer was availing power supply for DOMESTIC purpose only but consumer
 getting bill in commercial category, Line was disconnected in field from 08/2019 to
 01/2024, but entered in FG for bill stop on dtd. 21.11.2022 and reconnected after
 deposit of reconnection fee of Rs. 472/- with MR no. 4475120852401020001 on
 dtd. 08.05.2024.
- As per billing database the provisional bill was served from 07/2019 to 04/2024. And the category of the complainant is LT/ GP. And the security amount was adjusted against arrear on dtd. 15.03.2024.

ORDER 16.12.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill from 07/2019 to 01/2024 (excluding fixed charges).
- ➤ To revise the bill from 02/2024 to 04/2024 by taking 6 months average consumption of present meter (i.e. IMR "0" KwH on 05/2024 and FMR "1016" KwH on 10/2024) in LT/ Domestic category.
- To revise the bill from 05/2024 to 11/2024 in LT/ Domestic category.
- To serve the bill from 11/2024 onwards in LT/ Domestic category.
- ➤ The complainant is directed to pay the balance outstanding arrear and SD amount as appropriate, as per regulation 144 and 52 of conditions of supply code, 2019 of OERC.

The case is disposed of accordingly.
