GIST OF THE COMPLAINT:

The complainant consumer Late Sri Laxmikanta Saha, Repr. by Sri Dambrudhar Bhoi, At/Po- Laitara, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 17.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 2 KW having consumer no- 9033-0101-2673 under SDO Elect. Kesinga.
- 2) The provisional bill may be revise on the basic of actual meter reading.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 03/10/2024
- 2) Bill details from November 2007 to June 2024
- 3) Date of supply 22/10/2007
- 4) Category: LT/Domestic



- 6) Meter No TPWODL1116451
- 7) Installed on 17/01/2023 with IMR: "0"
- 8) CMR: N/A
- 9) The meter status: Bill Stopped
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
 - Provisional bill not been adjusted from 11/2016 to 09/2022.
 - As per PVR submitted by JE and Officer com. Kesinga on dated 03/10/2024 the line was disconnected in the field on dated 12/06/2024.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Provisional bill not been adjusted from 11/2016 to 09/2022.
- As per PVR submitted by JE and Officer com. Kesinga on dated 03/10/2024 the line was disconnected in the field on dated 12/06/2024.
- As per database the line was permanently disconnected from 05/2024.

ORDER

28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To revise the bill from 01/2021 to 12/2022 taking six months average consumption of new meter installed on 01/2023 taking IMR "0" KWH as on 01/2023 and FMR "23" KWH as on 06/2023.
- ➤ If the consumer wants to avail to power supply, he has to deposit the appropriate amount with reconnection charges

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
