GIST OF THE COMPLAINT:

The complainant consumer Sri Kishore Banchhor, Repr. by Sri Khageswar Banchhor, At-Boringpadar, Po/Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 08.11.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no-9033-0102-2887 under SDO Elect. Kesinga.
- 2) As complained by the complainant that the bill was raised without availing power supply.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the bill was raised without power supply.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from: 10/2018 to 09/2024



- 3) Date of supply: 28/10/2019
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No – WLT175804
- 7) Installed on: 28/10/2019 with IMR: "0"
- 8) CMR: 6143 Kwh as on 13/11/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
 - Average bill (without meter) from 10/2018 to 10/2019.
 - As per PVR submitted by JE and Officer com. Section officer Kesinga on dated 13/11/2024, consumer was availing power supply from 10/2019 and before that he was not using power supply.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Average bill (without meter) from 10/2018 to 10/2019.
- As per PVR submitted by JE and Officer com. Section officer Kesinga on dated 13/11/2024, consumer was availing power supply from 10/2019 and before that he was not using power supply.
- As per billing database the provisional bill was raised from 10/2018 to 09/2019.

ORDER

29.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill from 10/2018 to 09/2019 as the consumer was not availed the power supply.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
