#### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Bipra Banchhor, At- Boringpadar, PO- Kesinga, Ps- Kesinga, Dist.- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 27.05.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Dom supply with CD of 0.50 KW having consumer no- 9033-0102-2965 under SDO Elect. Kesinga.
- 2) As complained by the complainant the provisional/average bill was raised from 10/2018 to 10/2019.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.

#### SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

  - Average bill (Without meter) generated from October 2018 to October 2019.
  - As per PVR submitted by JE and Officer RCM Section office Kesinga on dated 07/06/2024 the consumer was availing power supply from 23/09/2018 and meter install on 28/10/2019.

#### FINDINGS / OBSERVATION? OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that average bill (Without meter) generated from October 2018 to October 2019.
- As per PVR submitted by JE and Officer RCM Section office Kesinga on dated 07/06/2024 the consumer was availing power supply from 23/09/2018 and meter install on 28/10/2019.

## ORDER 29.07.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019. The OP is directed as follows:

To revise the bill from 10/2018 to 10/2019 taking IMR "0" KwH on 11/2019 and FMR "80" KwH on 06/2020.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
