GIST OF THE COMPLAINT:

The complainant consumer Sri Judhistir Banchhor, Repr. By Smt. Basanti Banchhor, At- Boringpadar, PO- Kesinga, Ps- Kesinga, Dist.- Kalahandi comes under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 27.05.24, in brief as follows:

- The complainant has appeared before the forum for withdraw of EC bill during no power supply period of his LT/ Dom supply with CD of 1 KW having consumer no-9033-0102-2966 under SDO Elect. Kesinga.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 8) CMR: 57 KwH as on 07/06//2024
- 9) Meter Status OK
- 10) Facts of the complainant: Revision of bill

As written version submitted by SDO Elect. Kesinga as follows:

- Average bill (Without meter) generated from October 2018 to October 2019.
- As per PVR submitted by JE and Officer RCM Section office Kesinga on dated 07/06/2024 the consumer was availing power supply from 28/10/2019. Consumer was not availing power supply before 28/10/2019.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that average bill (Without meter) generated from October 2018 to October 2019. As per PVR submitted by JE and Officer-Com of Kesinga Section on dated 07/06/2024, the consumer was availing power supply from 28/10/2019.
- Average bill has generated from October 2018 to October 2019 is false as the consumer is availing power supply after installing the meter i.e 28/10 2019.
- From data base it is seen that bills from 8/2018 to 9/2019 were generated on LF basis showing without meter.

ORDER 29.07.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

• To withdraw the bill from October 2018 to September 2019 as the consumer has not availed the power supply.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
