GIST OF THE COMPLAINT:

The complainant consumer Smt. Sunita Sahu, Repr. by Sri Madhaba Sahu, AT-Boringpadar, Po- Kesinga, Ps- Kesinga, Dist.- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 13.06.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9033-0102-3002 under SDO Elect. Kesinga.
- 2) As complained by the complainant the provisional/average bill was raised from 10/2018 to 07/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from October 2018 to May 2024
- 3) Date of supply 01/08/2018
- 4) Category: LT/Domestic

- 7) Installed on 12/10/2022 with IMR: "0"
- 8) CMR: 2076 KwH as on 10/07/2024
- 9) The meter status OK
- 10) Facts of the complainant: Revision of abnormal bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
 - Average billing (without meter) from October 2018 to July 2022.
 - As per PVR submitted by JE and Officer Com. Kesinga on dt-10/07/2024 the consumer availing power supply from 12/10/2022.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that the average billing (without meter) was raised from 10/2018 to 07/2022.
- As per PVR submitted by JE and Officer Com. Kesinga on dt-10/07/2024 the consumer availing power supply from 12/10/2022.

ORDER 31.07.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To withdraw the bill from 10/2018 to 09/2022, as the power supply was availed on 12.10.2022.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
