GIST OF THE COMPLAINT:

The complainant consumer Smt. Mukta Banchhor, Repr. by Sri Kartik Banchhor, AT-Boringpadar, Po/Ps-Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 18.07.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- **9033-0102-3016** under SDO Elect. Kesinga.
- 2) As Complained by the complainant that the bill was raised prior to power supply.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 13/08/2024
- 2) Bill details from October 2018 to July 2024
- 3) Date of supply 01/08/2018
- 4) Category: LT/Domestic



- 5) Connected Load 1 KW
- 6) Meter No – WLT176120
- 7) Installed on 27/10/2019 with IMR: "0"
- 8) CMR: 689 KWH as on 13/08/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of abnormal bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
 - As per PVR given by Electrical section officer and officer commerce Kesinga on dated 09/08/2024, the consumer was availing power supply from 27/10/2019 and before that consumer was not availing power supply.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that as per PVR given by Electrical section officer and officer commerce Kesinga on dated 09/08/2024, the consumer was availing power supply from 27/10/2019 and before that consumer was not availing power supply. As seen from database bills were also generated an LF basis from 08/2018 to 09/2019 mentioning without meter.

ORDER

31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.


The OP is directed as follows:

- To withdraw the bill amount from 08/2018 to 09/2019 as the consumer was not availed power supply.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
