GIST OF THE COMPLAINT:

The complainant consumer Sri Sudhir Banchhor, At- Boringpadar, PO- Kesinga, Ps- Kesinga, Dist.- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 27.05.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Dom supply with CD of 1 KW having consumer no- 9033-0102-3076 under SDO Elect. Kesinga.
- 2) As complained by the complainant the provisional/average bill was raised from 11/2019 to 06/2020.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 5) Connected Load 1-KW
- 6) Meter No- WLT176036
- 7) Installed on 01/06/2020 with IMR: "1"
- 8) CMR: 1045 KwH as on 07.06.2024
- 9) Meter Status OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
 - Average bill (Without meter) generated from 11/2019 to 06/2020.
 - As per PVR submitted by JE and Officer RCM Section office Kesinga on dated 21/06/2024 the consumer was availing power supply from 01/06/2020.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that average bill (Without meter) generated from 11/2019 to 06/2020.
- As per PVR submitted by JE and Officer RCM Section office Kesinga on dated 21/06/2024 the consumer was availing power supply from 01/06/2020.

ORDER 29.07.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To withdraw the bill from 11/2019 to 02/2020, as the power supply was not available during the said period.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
