**GIST OF THE COMPLAINT:**

The complainant consumer Sri Barun Podh, Repr. By Sri Manjit Podh, At- Boringpadar, PO- Kesinga, Ps- Kesinga, Dist.- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 27.05.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Dom supply with CD of 1 KW having consumer no- **9033-0102-3109** under SDO Elect. Kesinga.
- 2) As complained by the complainant the provisional/average bill was raised from 05/2019 to 12/2020.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for;

To revise the provisional/average bill.

**SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 21/06/2024
- 2) Bill details from November 2019 to May 2024



- 3) Date of supply 17/05/2019
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No- LW469214
- 7) Installed on 03/01/2021 with IMR: "0"
- 8) CMR:835 kWh as on 21/06/2024
- 9) Meter Status OK
- 10) Facts of the complainant: Revision of bill

As written version submitted by SDO Elect. Kesinga as follows:

- Average bill (Without meter) generated from November 2019 to September 2021.
- As per PVR submitted by JE and Officer RCM Section office Kesinga on dated 21/06/2024 the consumer was availing power supply from 03/01/2021.
- Bill revision from 01/2021 to 06/2023 in FG.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for provisional/average billing. The OP submitted that average bill (Without meter) generated from November 2019 to September 2021.
- As per PVR submitted by JE and Officer RCM Section office Kesinga on dated 21/06/2024 the consumer was availing power supply from 03/01/2021.

### **ORDER** **29.07.2024**

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill from 11/2018 to 02/2020, as the power supply was not availed during this period.

The case is disposed of accordingly.
