GIST OF THE COMPLAINT:

The complainant consumer Smt. Binita Banchhor, At-Boringpadar Po/Ps- Kesinga, Dist.- Kalahandi comes under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 27.05.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Dom supply with CD of 0.50 KW having consumer no- 9033-0102-3259 under SDO Elect. Kesinga.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that excess billing in the month of 06/2021.
- As per database meter was install on 20/04/2021 but the reading has shown 1138 Kwh which seems to be table reading in the month of June 2021and then after readings were not taken properly up to February 2023.

ORDER 29.07.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from June 2021 to February 2023 taking IMR "0" Kwh in the month of June 2021 and FMR "1792" as of February 2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
