The complainant consumer Sri Kanar Harijan, Repr. By Sri Subhash Majhi, At-Bagad Ward No-1, Po-Kesinga, Ps-Kesinga, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 21.02.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.04 KW having consumer no- 9033-0104-3185 under EE, Elect. Sub-Division Kesinga
- 2) As complained by the complainant that abnormal excess bills were served in the month of 08/2019
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### **FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Excess bill from 05/2021 to 07/2022.
- As per billing data base the actual/provisional bills were generated from the date of supply to 07/2019 and the consumer also deposited the claimed amount from time to time but 2983 units was billed for the month of 08/2019 which seems to be supressed meter reading. secondly excess actual/provisional bills were served after installation of meter on dtd.31.01.2021

### ORDER 28.02.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 03/2016 to 08/2019 taking IMR "0" KwH on 03/2016 and FMR "6395" KwH on 08/2019.
- To recast the bill from 03/2021 to 02/2022 taking IMR "4551" KwH on 03/2021 and FMR "7111" KwH on 02/2022.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>March-25</u> the opposite party after compliance otherwise it will be treated as non-compliance.
