The complainant consumer Smt. Abanti Sahu, Repr. By Sri Bharatram Sahu, At- Kesinga ward no-18, Bagad, PO- Kesinga, Ps- Kesinga Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 16.03.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ DOM supply with CD of 1 kw having consumer No 9033-0104-3517 under SDO Elect. Kesinga.
- 2) As complained by the complainant the provisional bill was raised prior to date of power supply.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the provisional bill was raised prior to date of P/s.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for withdraw the provisional bill was raised prior to date of P/s. The OP submitted that the average billing (Without meter) was served to consumer from 09/2018 to 07/2022.
- As per PVR submitted by JE, Kesinga, the date of power supply is 26.09.2022

ORDER 14.05.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

> To withdraw the bill from 09/2018 to 07/2022, as the date of power supply is 26.09.2022 instead of 12.09.2018, as reported by the concerned ESO.

The case is disposed of accordingly.
