GIST OF THE COMPLAINT:

The complainant consumer Sri Paban Naik, AT- Sanpada, ward-5, Po/Ps- Kesinga, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 16.12.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9033-0106-3262 under SDO Elect. Kesinga.
- 2) As complained by the complainant that the bill was raised without power supply from 05/2019 to 08/2020.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw bill raised without power supply.

 As per PVR submitted by JE and Office com. Section officer Kesinga on dated 24/12/2024, consumer was availing power supply from 08/2020 and before that he was not using power supply.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Average bill (without meter) from 11/2019 to 08/2020.
- As per PVR submitted by Je and Office com. Section officer Kesinga on dated 24/12/2024, consumer was availing power supply from 08/2020 and before that he was not using power supply.
- As per billing database the average bill was served from 11/2019 to 07/2020.

ORDER 06.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To withdraw the bill from 11/2019 to 07/2020 as the consumer was not vailing power supply.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by January-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
