The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 08.11.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 3.5 KW having consumer no- 9033-0107-2284 under SDO Elect. Kesinga.
- 2) As complained by the complainant that the provisional bill was served from 06/2018.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:


To withdraw the provisional bill.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Excess billing in the month of 05/2024.
- As per PVR submitted by officer com. And JE Kesinga on dated 13/11/2024, house was locked from 07/2018 to 04/2024.
- As per billing database the provisional bill was served from 06/2018 to 07/2022. And the security deposit amount was adjusted against arrear on dtd.15.03.2024.

ORDER 16.12.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To revise the bill from 06/2022 to 05/2024 by taking 6 months average consumption of present meter installed on 29.05.2024.
- > The complainant is directed to pay the SD amount as appropriate as per regulation 52 of conditions of supply code, 2019 of OERC.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
