GIST OF THE COMPLAINT:

The complainant consumer Sri Krishna Sabat, Repr. by Sri Nilamani Padhi, AT/Po-Kesinga, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 18.07.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ GP supply with CD of 1 KW having consumer no- 9033-0108-0554 under SDO Elect. Kesinga.
- 2) As complained by the complainant the bill has raised in LT/GP category instead of LT/Dom.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the billing category.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 09/08/2024
- 2) Bill details from April 2021 to July 2024
- 3) Date of supply 28/04/2021



- 4) Category: LT/General Purpose
- 5) Connected Load 1 KW
- 6) Meter No WLT251311
- 7) Installed on 27/04/2021 with IMR: "0"
- 8) CMR: 5317 KWH as on 09/08/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bills has raised LT/GP category instead of Domestic
- 11) As written version submitted by SDO Elect. Kesinga as follows:
 - As per PVR given by the ESO and Officer commerce Kesinga on dated 09/08/2024, the consumer was availing power supply in Domestic purpose from January 2022, but consumer is getting bill in Commercial tariff.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for change of billing category. The OP submitted that
 as per PVR given by the ESO and Officer commerce Kesinga on dated 09/08/2024,
 the consumer was availing power supply in Domestic purpose from 01/2022, but
 consumer is getting bill in Commercial tariff.
- As per billing database the bill has served in LT/ GP category from 04/2021 to till 08/2024.

ORDER 31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To change the billing category from LT/GP to LT/Dom, and recalculate the bill from 01/2022 to till 08/2024 in LT/Dom category.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
