## **GIST OF THE COMPLANT:**

The Complainant Sri Baladev Purohit appeared before the Forum during the camp court held at Utkela on dt. 14/11/2023 for abnormal billing done for the domestic connection owned by him from 03/22 to 03/23 due to meter defect.

#### SUBMISSION OF COMPLAINANT DURING HEARING:

The complainant reiterated his complaint regarding abnormal billing done against the domestic connection owned by him from 03/22 to 03/23. He requested to revise the abnormal billing with high units for the above period as per the consumption pattern of the present meter.

## SUBMISSION OF OPPOSITE PARTY DURING HEARING:

The OP (SDO Kesinga) has submitted the following documents:

- a) A written Statement, stated that:
  - > The consumer was billed on provisional/average basis from 10/2013 to 09/2015 and excess billing raised from 03/2022 to 01/2023.
  - As per physical verification report of ESO & AOC of Utkela section, the meter is working OK.
- b) PVR Dtd. 08/12/2023 was submitted mentioning meter number as 300011099 and CMR as "3046" with load 2.246 KW.



From the database and statement as submitted by SDO(Elect.) Kesinga, the Forum observed that abnormal billings were raised with high units due to meter defect from 03/22 to 03/23. The consumer was also aggrieved for such abnormal bills, which were served to him.

# ORDER 01.01.2024

Based on the above observations, the Forum passes the following order as per regulations 155 of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bills for the period March-2022 to March-2023 on six months average consumption of the present meter i.e. from April-2023 taking IMR as "583" to September-2023 taking FMR as "2654".

Case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
