GIST OF THE COMPLAINT:

The complainant consumer Sri Chatura Majhi, At- Dumermunda, Po- Kikia, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 19.10.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no-9033-0217-5881 under SDO Elect. Kesinga.
- 2) As complained by the complainant the provisional bill has serve though the meter was running.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

• The complainant reiterated for excess billing.

• The OP stated that Excess billing in the moth of 04/2023.

• Provisional and average bill from 05/2023 to 10/2023.

ORDER 05.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To recast the bill from 12/2020 to 04/2023 by taking IMR "0" KWH on 12/2020 and FMR "4717" KWH on 04/2023.

➤ To revise the bill from 05/2023 to 10/2023 by taking six-moth average consumption of new meter install on 11/11/2023 with IMR "0" KWH on 11/2023 and FMR "124" KWH on 04/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
