#### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Parikhita Sahu AT/Po- Chancher, Ps- Kesinga, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 18.07.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.50 KW having consumer no- 9033-0220-0087 under SDO Elect. Kesinga.
- 2) As Complained by the Complainant that the Average/Provisional bill was raised during the month of 04/2014 to 08/2015 & 02/2019 to 09/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

### **SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 09/08/2024
- 2) Bill details from February 2001 to July 2024
- 3) Date of supply 01/01/1990
- 4) Category: LT/Domestic



- 5) Connected Load 0.50 KW
- 6) Meter No TWSP51033353
- 7) Installed on 16/09/2023 with IMR: "0"
- 8) CMR: 21 KWH as on 09/08/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
  - Average billing from the month of April 2014 to august 2015.
  - Provisional bill from February 2019 to September 2023 as from 10/02/2019 to 15/09/2023 there was no power supply due to disconnection.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that Average billing from the month of April 2014 to august 2015.
- Provisional bill from February 2019 to September 2023 as from 10/02/2019 to 15/09/2023 there was no power supply due to disconnection

## ORDER 31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To withdraw the bill amount excluding the fix charges for the period from 02/2019 to 09/2023 as the power supply was disconnected
- To withdraw the DPS amount claimed from 10/2021 to 09/2023 as it is a domestic category consumer.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
